### **Key accomplishments**

#### *Student Funding*

- Secured buy-in from the Cabinet, Council of Deans, and faculty to implement a five year/\$34,000 (now \$36,000) funding guarantee for all admitted doctoral students starting in fall 2022.
- Increased fundraising for graduate fellowships, including working with UDAR to develop the blueprint for a graduate support campaign that raised over \$420 million, including 58 \$1 million endowed fellowships, a \$2 million current use fellowships gift, and a \$26 million renewal and expansion of the MasterCard Foundation's African Scholars program.

#### *Diversity, Outreach, and Admissions*

- Dramatically expanded the outreach Berkeley does with prospective applicants, including almost tripling the number of programs eligible for fee waivers and establishing an annual [Graduate Diversity Admissions Fair](#) (with over 8,500 registrants in fall 2023);
  - Admitted the largest number of underrepresented doctoral students in the university's history in fall 2021;
- Implemented an [Admissions Institute](#), a set of four workshops to support staff and faculty engaged in admissions in order to ensure they know the latest research on how best to engage in holistic admissions and rubric development;
- Designed and ran an annual five-week [Pipeline to Graduate School Bootcamp](#), with over 1,000 participants from across the county each year. Sessions focused on helping students learn more about graduate school and the graduate application process.

#### *Student Experience/Belonging/Wellness*

- In partnership with the Division of Equity and Inclusion, launched a [Neurodiversity Task Force](#), to develop recommendations for adapting coursework and/or milestones to support neurodivergent graduate student needs.
- Created the [Diversity and Community Fellows program](#). Fellows work across and within academic units to create healthy communities for graduate students. Critical components of this work include supporting an inclusive graduate community and enhancing the cultural, academic, and professional experience of historically underrepresented students at Berkeley;

- Established an [Inclusive Excellence Hub](#), a dedicated space for minoritized graduate students to meet, receive supportive programming, and develop a sense of belonging (a partnership with the Division of Equity and Inclusion);
- Developed the [Path to the Professoriate](#) program, a year-long set of workshops for first year URM graduate students designed to demystify the academy and academic career paths;
- In collaboration with the Educational Psychology program and Graduate Wellness Program, created a [Graduate Peer Support Provider](#) program. Peer support providers meet one-on-one with graduate students to provide assistance in navigating the complex processes related to mental health, basic needs, and academia;
- Designed and implemented a [Graduate Diversity Leadership Academy](#), a year-long program focused around the ABCD “pillars” of DEIBJ in graduate education: Admissions, Belonging, Climate, and Data for Equity;
- Invested \$1.5M to create the [Graduate Diversity Pilot Program](#), which funded nine departments for four years to improve climate and belonging within their graduate programs.

#### *Professional Development*

- Partnered with multiple campus administrative units to establish the new [Future of Higher Education Postdoctoral Fellowship](#) program for Berkeley PhDs;
- In collaboration with Berkeley’s D-Lab, designed and launched a summer [Data Science and Social Justice Workshop](#) for students, a 6-week program designed to provide students with essential tools and methods for critical data science analysis, held annually since 2022;
- With \$2M in donor support, designed and launched a [Graduate Remote Instruction Innovation Fellows](#) program that provided eight weeks of intensive instruction to participating fellows to support their remote instruction in fall 2020 and four weeks of intensive instruction to support remote teaching in spring 2021.

#### *Crisis Management*

- Created a rapid response team to address the many challenges that arose from the COVID crisis, including ensuring relevant Senate policy changes were made (e.g., normative time extension, grading policy clarification, flexibility with milestones, etc.); shifting internal Graduate Division policies, including extending deadlines and making degree filing easier and less costly to students; working closely with basic needs to ensure that funding got to students as quickly and as equitably as possible; and creating a comprehensive COVID-19 site that summarized all the most up-to-date information relevant to graduate students.
